## PERFORMANCE CONTRACT

This agreement is made between Glenn Green Music (referred to as ARTIST) and the organization and/or representative listed below (referred to as PURCHASER). This contract signifies a mutual agreement by the ARTIST and PURCHASER. The PURCHASER hereby engages the services of the ARTIST and the ARTIST hereby agrees to furnish the entertainment presentation(s) herein described according to the terms and conditions set forth in this contract and all pertaining riders.

### 3. TECHNICAL REQUIREMENTS

- **Sound:** ARTIST is able to provide complete sound system if necessary but will require confirmation from PURCHASER.
- **Lighting:** Supplied by PURCHASER, as appropriate to venue.
- **Media:** ARTIST is able to offer presentation of lyrics through Media Shout or Power Point provided PURCHASER supplies projector and screen.

### 4. ARTIST SERVICES

- ARTIST agrees to provide a minimum 1-6 piece team consisting of acoustic guitar, bass, drums, flute, electric and vocals.
- ARTIST agrees to provide appropriate Christian-based music throughout event during agreed upon sessions.
- ARTIST agrees to provide necessary instruments and instrument cables.

## TECHNICAL RIDER

- **Minimum of 2 standard, grounded electrical outlets within 25' of staging area.**
- **Prefer a center staging area of 8' x 10' or greater.**
- **If outside, ARTIST prefers staging areas to be covered.**
- **ARTIST requests that PURCHASER provide water during sessions.**
- **If driving, ARTIST requests .50¢/mile**

- **If flying, ARTIST requests full reimbursement for tickets**

PURCHASER acknowledges that he/she has read and approves the terms and conditions set forth in this agreement. **The PURCHASER'S signature confirms that he/she is in agreement with all information contained in this contract, as well as attached riders.** This agreement is not confirmed until it is signed by both parties and returned to Glenn Green Music productions. If PURCHASER should cancel the event for any reason within 30 days prior to the event, it is understood that 50% of the Payment/Honorarium shall be paid to the ARTIST. If PURCHASER should cancel the event for any reason within 15 days prior to the event, the full contracted amount shall be paid to the ARTIST. Any cancellations must be made in writing and delivered to Glenn Green Music.
